3. Future of M.C.L.T:

Resolution:

THE BOARD OF THE M.C.L.T DO NOT SUPPORT THE NORTHWICK ROAD SITE DUE TO THE FLAWED COMMUNITY CONSULTATION PROCESS, ROAD SAFETY CONCERNS AND FLOODING ISSUES AND WILL ROBUSTLY OPPOSE ANY PLANNING APPLICATION FOR THIS SITE. THE RESOLUTION WAS CARRIED UNANIMOUSLY.

The board also resolved to advertise for new sites to come forward and to enquire via the parish magazine if anyone had any plots of land for sale. Amanda Bradley to talk to Les Smith as he has many local contacts in this sector. All agreed that a solution nearer to Mark First school that incorporated a new drop off/pick up point as part of any CIL would be more beneficial to the village.
